2022 Data Entry Deadlines

Quarter 3 forms for 2022 data will be due on 30th November 2022.

This includes all clinical measures, hospital/clinic visits/ microbiology and completion and the quarterly sign-off form.

For those sites that will send through their data via templates for upload, we would appreciate this prior to the deadline date.

Pilot to Improve Data Capture in the ACFDR

In order to improve data capture in the ACFDR, we have been given approval by the ACFDR Steering Committee to pilot modified quarterly data payments.

Quarterly payment will be determined by the presence or absence of clinical data in the remaining quarters for 2022.

For the next period of data capture (Q3 and Q4 2022), payment is allocated to those records with quarterly clinical data available.

The rationale is to incentivise all sites to capture any data performed in the quarter, in order to maximise data completeness in the ACFDR. The pilot audit performed, showed some inconsistencies with missing data compared to what was present in the electronic medical record.

Physiotherapy Surveys in the ACFDR

A proposal to the ACFDR SC for the database to include physiotherapy items as a separate module in the registry has been put forward.

CF physiotherapists will be responsible for collecting survey data during routine outpatient appointments and then entering the airway clearance techniques and physical activity data into the database.
